## **City of Rome Project Related Incentives**

- 1. RESTORE NY Mixed-Use Building Renovation Grant (AVAILABLE IMMEDIATELY)
  - a. \$2 million in reimbursable financial assistance through Empire State Development Corp.
- 2. City of Rome Commercial Façade Improvement Program (First Come First Serve Basis)
  - a. Up to \$100,000 in exterior building improvements
- 485-b Commercial, Business, or Industrial Property Tax Exemption (Rolling Basis)
  - a. 50% deescalating 10-year exemption on the increase in assessment due to improvements to a commercial business or industrial property.

# **Oneida County Industrial Development Agency Project Related Incentives**

- 4. State and local sales tax exemption on building materials/supplies (Rolling Basis)
  - a. Applies to purchase of Furniture Fixtures & Equipment not automatically exempt
- 5. Exemption on 0.75% tax on real estate mortgages (Rolling Basis)
- 6. Payment In-Lieu of Tax (PILOT) through OCIDA (Rolling Basis)
  - a. 100% 10-year deescalating property tax exemption
- 7. Gap financing (Rolling Basis)
  - a. Low-interest loans to fill budget gaps
